- Unlimited passes expire according to type of pass and the date of purchase.
- 3/6/9/12 month commitment passes have credit card reoccurring monthly charges until the end of the committed term. A \$50 cancelation fee will apply to passes that are canceled before the end of the committed term.

## Agreement of Release and Waiver of Liability

1. Any type of yoga requires physical exertion that may be strenuous and may cause physical injury, and I am fully aware of the risks and hazards involved.
2. It is my responsibility to consult with a physician prior to and regarding my participation in any yoga class/workshop. I represent and warrant that I am physically fit and have no psychological, medical or emotional condition that would prevent me from safe participation in any yoga class/workshop.
3. Instructors may provide physical adjustments during class. It is my responsibility to inform the instructor at the beginning of class if I do not want such physical adjustments. It is also my responsibility to inform the instructor when an adjustment has gone as far as I desire at that time.
4. All class passes and memberships are non-refundable, non-transferrable and may not be suspended at any time for any reason, including, but not limited to vacation, illness and injury. Class passes expire one year after first use.
5. I give unrestricted permission to use and publish photographs or video images taken of me in any yoga class/workshop or at the studio, or in which I may be included, for any purpose authorized by Rebirth Hot Yoga, including but not limited to social media or website use, editorial publications and advertising use. This includes the right to modify and retouch the images. The circulation of such materials could be worldwide and I am aware that there will be no compensation to me for this use and that I will not be given the opportunity to inspect or approve the finished products or the advertising copy or the printed matter that may be used in connection therewith.

I release and discharge Rebirth Hot Yoga, its directors, and the Rebirth Hot Yoga instructors, adjusters, staff and volunteers from any and all liability, claim, demand or action that I may have resulting from injury, death or damages arising from my participation in the yoga class/workshop or at that yoga studio, including loss that may be caused by the negligence of the released party.
